CESR- At a Glance

#### Genesis

Centre for Environmental and Socio-economic Regeneration (CESR) is a non-government organisation (NGO) working for environment protection and socio-economic development of tribal and economically backward communities. CESR was founded by a group of development professionals with hands on experience in agriculture, horticulture, social work, health, education, women and child development, and management. The organisation was registered in Kolkata in 1993.

CESR works in the communities and villages of tribal, marginalised and economically backward people in West Bengal. Since its inception in 1993, CESR has been working in the tribal and backward caste dominated villages in Purulia district of West Bengal. At present, the organisation works in 211 villages in the community development Blocks of Hura, Puncha, Kashipur, Manbazar-II, Bandwan, Barabazar, Bagmundi, Arsha, Jhalda-I & II and Purulia-I in the district of Purulia in West Bengal. The villages were selected because of their socio-economic backwardness and environmental degradation due to deforestation.

### Our Vision

We envision – Social empowerment and economic development of tribal, backward and marginalised community, and protection of the environment through responsible use and management of natural resources.

#### **Our Mission**

Our Mission is to create an enabling environment where people, especially the disadvantaged and marginalised community can participate in development process with equity and bring about overall well being of masses by restoring and sustaining the productive natural resource-base.

## **Our Strategy**

Our strategy is built on the organisation's deep-routed presence in the tribal and backward areas, understanding the lives, practices and issues of the people living in those areas, and its knowledge of how to promote social justice, equity and dignity for all citizens, especially the socially excluded and economically marginalized citizens and communities.

CESR's strategy to achieve its Mission comprises of three inter-related elements:

- To mobilise local people, particularly the tribal and marginalised community, plan and implement long term programs for sustainable environmental and socio-economic development through active participation ofpeople.
- To work with various development organizations, government and Partners in implementing various projects on environmental and socio-economic regeneration
- To support various development partners in building their capacity, implementing and managing their activities through training, consulting, research & studies

• To promote ecologically sustainable development and improvement of Quality of Life (QOL) through strategies for collective well being.

To bring in economic development of tribals and economically backward communities through various local resource based practices

- To preserve cultural heritage with special emphasis on folk and tribal culture in rural areas and codify indigenous knowledge systems.
- To empower poor women economically, and give them a voice, increase awareness of women's rights, and ensure their access to basic services, control over natural resources, appropriate new technology and financial services.
- To create legal awareness among the poor and marginalised people.

# Projects in 2019-20

# **IIMPACT- Girl Child Education Project**

The main reasons for low enrolment and high drop out of girls at the primary level are: parents' seasonal migration, sibling care, and domestic work. Lack of awareness among the peer group also contributes to child marriage and child trafficking cases.

With a view to increasing the poor literacy rate among women in Purulia district, CESR initiated 25 learning centers under the Girl Child Education Programme at Purulia-I and Bandwan blocks with financial support from IIMPACT, New Delhi. IIMPACT is an initiative of alumni of the Indian Institute of Management, Ahmedabad, India.

The Programme has been taken up with the long term vision of transforming the lives of women, families and entire communities in India by education and empowerment of the girl child.

The mission of the programme is to mobilize and motivate non-school going girls, between the ages of 6 and 14, from economically and socially backward rural areas of India, and put them firmly on the track of literacy through quality primary education.

Girl Child Education Programme focuses on primary education of underprivileged girls who have never gone to school because of the prevailing

village norms. Educating the girl child helps transform her gait and confidence level. She becomes an agent for change. Later, in her turn, as a mother, she ensures the education of her children and objects to child marriages and other social ills.

## Childline-1098

Childline-1098 is a phone outreach based intervention model whereby on receiving a call for help the local Childline teams swing into action for direct intervention. Intervention covers a range of actions from rescuing children from abusive circumstances, providing immediate SOS attention, to registering

Each case consumes time based on its individual requirements. Childline's operational model involves the team activating a variety of linkages among the allied system institutions such as Police, municipality, health care, education and transport institutions along with the judiciary, child care NGOs, local state and central governments. More than often, the team has to provide unique solutions that require a relevant interpretation of legislations such as the Juvenile Justice Act and others and sensitize allied institutions to issues.

## nternet Saathi (May'2019 to January'2020)

## Digital Literacy Programme

CESR, Purulia, successfully completed its four consecutive phases of the Internet Saathi Project in twelve (12) respective blocks of Purulia District & in six blocks of Bankura District. Afterwards, similar work started in remaining 16 other blocks of Bankura District, all blocks of Uttar & Dakhin Dinajpur during May'19 to January'2020 with the support of FREND, Gurgaon (A Joint initiative of Google India Pvt. Ltd & Tata Trusts). For smooth implementation of the project in two new locations, we have made partnership with local level NGOs like Naari Mukti Mahila Samiti (NMMS) for Dakhin Dinajpur & Shripur Mahila -O-Khadi Unnayan Samity (SMOKUS) for Uttar Dinajpur.

Overcoming hurdles and establishing rapport in newly adopted two new Districts, CESR kick started its fifth phase successfully.

The Preliminary Activities were as follows:


- State Coordinator for all three districts, District coordinator for each District and 35 nos. of Block Co-ordinators for the proper implementation of the project were hired.
- Village Mapping: As per project norms, District Coordinator & each Block Co-ordinators created a cluster of 4 villages (for each and every saathi) basis Census Village list 2011 provided through Google and Tata Trust sources (FREND).
- Selection of 1055 Saathis (458 from Bankura, 286 from Uttar Dinajpur & 311 from Dakhin Dinajpur) from all the blocks of three Districts.
- Orientation Programme for all the Saathis of three Districts.
- Training Programme for the Saathis by PMG group in presence of PMG representatives and IL&FS trainers, in all the Districts.

## Adolescent Empowerment Programme

Adolescence is a period of transition from childhood to adulthood. It is characterized by rapid physical, biological and hormonal changes resulting in psycho-social, behavioral and sexual maturity in an individual. Adolescents are leaders in the making their ambition, creativity, curiosity, drive and eagerness create a fertile ground for planting seeds for their bright future. However, at this stage adolescents struggle with self- identity, peer acceptance, parental approval and overall societal belonging. During this second decade of their life they begin to question the meaning of life, inherited family beliefs, values and norms. They are extremely self-conscious of actions, behaviors and characteristics, continuously judging themselves through a critical lens. Both boys and girls have limited knowledge, skills and exposures to handle their problems and challenges within the existing environment. Anemia and malnutrition are also major factors which affect adolescent's physical development. In adolescent girls, it has been observed several times that nutritional deprivation among them reduces their school attendance, learning ability and overall performance. Adolescent boys in India face different sets of problems; their own inhibitions do not allow them to express their problems and needs easily. More than 33% of the disease burden and almost 60% of premature deaths among adults can be associated with behaviors or conditions that began or occurred during

adolescence- for instance tobacco and alcohol use, poor eating habits, violence, sexual abuse, and risk taking behavior. Of the total population of the Purulia district, nearly 20.23% are adolescents.

CESR has been implementing the Adolescent Intervention Programme at Barabazar block of Purulia district of West Bengal with the objectives of reducing the incidences of child marriage, increasing the adolescents' enrolment in secondary education, and reducing adolescence pregnancy and motherhood.

The programme has been working hard towards strengthening various government schemes for adolescent girls and boys, re-enrolment of out of school children, strengthening VLCPC, creation of awareness on the evils of child marriage, participation in government meetings and Training on
